A Note from the County Chair

Fellow Democrats,

I shared this story at the August breakfast...when my husband asked me ten years ago to consider moving to Greenville, my response was that I'd have to do a little research before I could definitively answer. One aspect I subsequently examined was county and city levels of government. And I was totally intrigued by the fact that Greenville City Council, at the time, was majority women (5:2) and the majority of them were Democrats (4:1)!

Greenville County Council was a different story altogether; nevertheless it was clear then that female and Democratic leadership was valued and was at the helm of shaping the vision and policies that have made the City a model for public/private partnership and revitalization. Gender and political party ratios have shifted during the intervening years and, this year, two of the three City Council seats held by Democrats are on the ballot. With Greenville now facing issues of rampant growth and income and access inequality, it is IMPERATIVE that incumbent Councilwoman Lillian Brock Flemming and At-Large candidate Russell Stall win on November 7. Their voices for balanced growth, economic opportunity, and equity for all must prevail. In addition, Dexter Reaves is running for the Greer City Council District 6 seat. While that race is nonpartisan, Dexter will bring strong Democratic Party values to his service in his community. Equally as important, since this is the first election for the GCDP since last November, it is to some degree a referendum on our ability to mobilize the electorate and a precursor to the 2018 election cycle. That means that every one of us must participate in some form or fashion to secure victory. There are a variety of ways in which to be involved, so please read through this list, select one (or two or three), and let us know at Headquarters what you will do to ensure that the cities of Greenville and Greer move forward smartly and intentionally with the needs and dreams of all residents represented:

- **Phone bank between now and November**
 - The campaigns have regular phone banking opportunities through which likely voters are identified and engaged to prepare for getting out the vote (GOTV); call lists and scripts are provided
- **Canvass neighborhoods between now and November**
 - The campaigns also hold regular canvassing opportunities through which likely voters are identified and engaged to prepare for GOTV; training with maps and scripts is provided
- **Deliver yard signs and campaign materials or help with campaign meet & greets and community events**
- **Drive voters to the polls**
 - We'll do this during the absentee voting period expected to run weekdays from October 9 to November
 - We'll also need drivers on Election Day, November 7 between 7am and 7pm

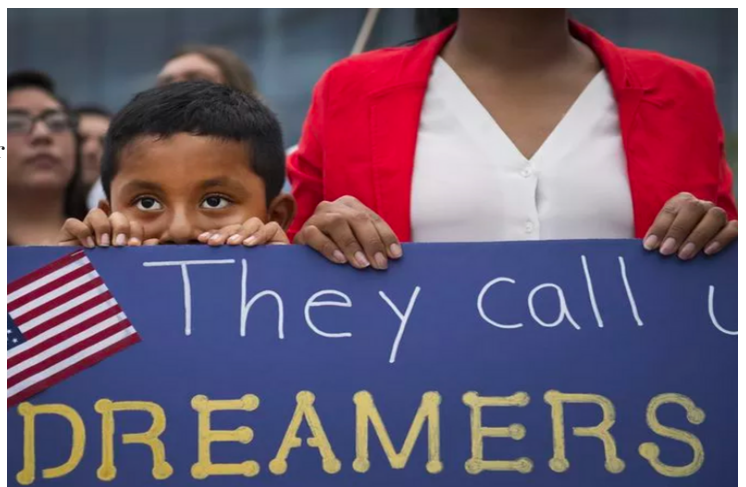

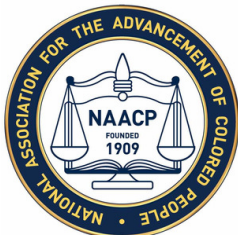

If you happened to stop by the GCDP office this summer, chances were high that you ran into one of the many interns working with us between June and August. They worked on a myriad of projects including the Archie Parnell and Jon Ossoff special election races, Planned Parenthood phone banks, Lillian Brock Flemming's and Russell Stall's Greenville City Council campaigns, voter registration and data entry, the Resistance Summer effort, inventories and scheduling, and general office support.

Governor Protects Richard Quinn and Associates Instead of Rate Payers

COLUMBIA, SC --

Chairman of the South Carolina Democratic Party Trav Robertson called on Henry McMaster or his staff to disclose any knowledge of the relationship between the executive director of the Office of Regulatory Staff Dukes Scott, Richard Quinn, Richard Quinn's son-in-law, and the Governor's office. The Office of Regulatory Staff ("ORS") at the Public Service Commission has been leading the push for the V.C. Summer plant since the beginning. Our lawmakers trust their expert advice on complicated regulatory and technical matters. They repeatedly recommended rate hikes to the Legislature for approval, which have now totaled over \$1.4 billion. Despite a clear call from House Speaker Jay Lucas and other members of the General Assembly for the resignation of ORS Director Dukes Scott, Henry McMaster's refusal to accept his resignation demonstrates that accountability is not the main objective of the Governor's office. The Governor and his staff have once again moved to protect an ally of the Quinns. At ORS, Dukes Scott hired Richard Quinn's son-in-law, who has since moved to Willoughby & Hoefer, a firm closely connected to Attorney General Alan Wilson. These events and relationships do not appear to be a coincidence. "Henry McMaster has placed the cost of a failed business scheme on the backs of ratepayers to protect the friends of his consultants. This is one of the largest bailouts in the history of South Carolina."

The Quinnndom Begins to Unravel

In the summer of 1990, South Carolina's ongoing problem with political corruption drew national attention when the FBI revealed an undercover investigation named Operation Lost Trust. When indictments were handed down the Statehouse sting ensnared dozens of lobbyists and lawmakers. Operation Lost Trust ended with 27 guilty pleas and convictions, 17 of them from state legislators. Decades later political corruption at the SC state capitol continues unabated. The latest charges stem from a 2013 SLED investigation that centered on the messy campaign spending practices of long time House Majority leader Bobby Harrell. In the fall of 2014, Harrell pleaded guilty to misconduct in office and resigned. He admitted using his campaign funds for personal expenses. Harrell also began cooperating with special prosecutor David Pascoe. The probe has been slowed by Attorney General Alan Wilson, who stepped away from Harrell's prosecution and appointed special prosecutor David Pascoe. When Pascoe turned his attention to long time political consultant Richard Quinn, Wilson tried to have him removed and repeatedly disparaged him in public. The SC Supreme Court finally upheld Pascoe's appointment and the investigation continued. Richard Quinn and his son Rick Quinn are long time political operatives in Columbia, the State newspaper refers to their business as the "Quinnndom."

Columbia based Richard Quinn and associates has a vast network of clients including the University of SC, Attorney General Alan Wilson, state treasurer Curtis Loftis, Senator Lindsey Graham, US Rep. Joe Wilson (Alan Wilson's father), and our current governor, Henry McMaster. Richard Quinn Senior serves as the political consultant while his son state Representative Rick Quinn handles the clients' direct mail and marketing. Indicted state Senator John Courson's case provides a case study into the Quinn corruption scheme. Courson a 72 year old Columbia Republican, is accused of funnelling \$250,000 into Quinn's consulting firm and getting \$133,00 back for his personal use. The crux of the scam is this, since South Carolina is totally dominated by Republicans, once they win their seats they still raise money like it's a hotly contested race.

They funnel the money to the Quinns for “consulting” work and direct mail, the Quinns charge far less for the work, if it’s performed at all and hand the money back to their clients. Courson has been in the state senate since 1985, so one can assume he has a safe seat. Pascoe claims 54% of the money Courson paid into the Quinn’s firm was kicked back to him personally. Since 2009 Courson has paid Quinn \$533,000 for consulting and campaign work. Richard Quinn’s long term relationships with Governor McMaster, Attorney General Alan Wilson and Senate Majority leader Hugh Leatherman could possibly ensnare them as well as other top ranking state legislators. Rep. Jim Merrill who was named in the 2013 SLED report, recently pleaded guilty to a misconduct charge and has been removed from office. Merrill has also agreed to continue cooperating with Pascoe. This investigation is far from over and now that it’s focused on the Quinns and their clients, it’s picking up speed. Stay tuned, this is the best soap opera in South Carolina.

Money is the Mother's Milk of Politics

Following the losses of the Presidential Election last November, we’ve seen an awakening of the Greenville County Democratic Party like never before. Our monthly meetings have seen attendance increases of **500%**, our email lists have grown and are allowing us to reach thousands more Democrats in the Upstate, and our programming has seen an increase in attendance and press coverage.
